

# NETBALL RULES & REGULATIONS

### 1. Introduction

1.1. This tournament will be based on the Malaysian MSN Rules, IFNA International Netball rules, and the domestic Rules & Regulations as formalize by the 11<sup>th</sup> Lion Group Cross Country & Sports Carnival 2011, Games Committee.

#### 2. Player

- 2.1. Open to all staff of the Lion Group with the age of between 18 years and above.
- 2.2. Each Group of Company will be represented by **ONE Playing Team** which will comprise up to a maximum of 10 players.
- 2.3. All players must be ladies.

#### 3. Game format

- 3.1. This tournament will be played on a "Knocked Out" basis.
- 3.2. 10 teams will be divided into 5 groups for the Semi Finals.

#### 4. Winning Point

- 4.1. The winning point will be based on the score and the overall timing of each game will be 11 minutes. Each game will have a time limit of 10 minutes and a 1 minute time break.
- 4.2. The final match will be played with an overall game time of 15 minutes, with 14 minutes of game play and a 1 minute time break.

## 5. <u>Wear Apparel/ Clothes</u>

- 5.1. Every player will be required to wear proper sports attire representing the respective team. Game shoe is a requirement for all players.
- 5.2. Safety shoes, sandals, slippers and any other in-proper form of footwear are strictly prohibited.

# 6. <u>Time</u>

- 6.1. The election for the grouping will be held during the team registration on 1st day of the Sport Carnival 2011.
- 6.2. Each team captain shall provide the name list of players to the Referee, 10 minutes before game starts.
- 6.3. If any of the participating team fails to comply to the regulation as stated in sub paragraph 6.2, the team concern will be disqualify and the opponent team will be given a Free Winning Point.

# 7. Walkover

7.1. Any participating Team who may decide to withdraw from the game will not be allowed to compete in the next game and the results achieved by the respective Team will be eliminated.

# 8. Objection

- 8.1. All game results as announce by the Referee shall be final.
- 8.2. Any objection to the game result shall be referred to Sports Carnival 2011 Netball Game Committee.
- 8.3. In order to raise any objection, the team must verbally notify the Court Referee during the incident through the respective Team Captain. The Court Referee will immediately indicate as the 'Objection Made' in the marking sheet for further procedure and actions by the Sports Carnival 2011 Netball Game Committee.
- 8.4. Any official objection must be made to Sports Carnival 2011 Netball Game Committee within half an hour, after the ended, to ensure that a judgment can be made before the next game.
- 8.5. All official objections must rise in writing with an enclosed payment of **RM100** (Ringgit Malaysia One Hundred Only). Objection without payment will not be entertained.
- 8.6. The payment will not be refundable for whatever the results made and the decision by the Juror which will be made in writing is Final.

## 9. Composition of the Juror.

- 9.1. The Juror shall consists of between 3 -5 persons (which will be appointed at random) and will be headed by the Chairman of Sports Carnival 2011 Cross Country Netball Committee. (No interested party / other Team Leader / Member will be appointed as members of the Juror)
- 9.2. Body of Juror will be in discussion to affirm the Official Objection and make the final decision.

## 10. Other Matter.

10.1. Any other terms not specifically written in this Rules & Regulation will be decided upon by Sports Carnival 2011 Netball Game Committee.
